Shimakanishat, *Rangers* Kanata-assit mak innu-shimakanishat napeuat mak ishkujeuat, iapit anitshenat e uinakaniht tshiashi-shimakanishat *Forces armées canadiennes* (FAC) mak *Gendarmerie royale du Canada* (GRC), ashit uikanishuaua, tshipa tshi katshitinamuat tshekuannu tshetshi uitshikuht mak tshetshi aitutuakaniht tshetshi ut minuinniuh mak minuenimuht.
