Overview

- VAC's Supplementary Estimates (A) were approved by Parliament in June in the amount of \$87,725,159.
 - This increased the Department's budget to \$5,325,427,413.
- In September 2020, the Department received \$12,511,069 for the 2019-20 to 2020-21 Operating Budget Carry Forward.
 - This brought the Department's overall budget to \$5,337,938,482.
- Through these Supplementary Estimates, the Department's budget will be increased by \$33.4M.
 - This will bring the Department's overall budget to \$5,371,335,883.



Veterans Affairs Canada 2020-21 Fall Supplementary Estimates (B)

Veterans Affairs Canada's 2020-21 Supplementary Estimates (B) submission totals an increase of \$33.4M and includes the following:

Reprofiles

· Funding of \$9M to continue payments for the Toth class action settlement agreement.

Transfers from other departments

- \$377K from the Canadian Institutes of Health Research to adjust funding previously provided to support research on the potential therapeutic benefits and harms associated with cannabis use.
- \$13K from the *Department of Foreign Affairs, Trade and Development* to adjust funding previously provided for departmental staff located at missions abroad. This transfer represent unspent funds due to exchange rate fluctuations.

Transfers to other departments

- \$4.5M to National Capital Commission for the construction of the Afghanistan Memorial
- \$29K to Canadian Heritage for the construction of the Afghanistan Memorial
- \$169K to TBS to support the GoC Financial Material Management Solution Project (GCFM)

Increases to Grants from Contributions

Increase of \$450K to the Grant for Commemorative Partnerships to support a high number of grant applications versus contribution applications.

Increases to Statutory Items

• Due to the introduction of Bill C-2 in Parliament, An Act relating to economic recovery in response to COVID-19, VAC's Supplementary Estimates B contains \$20M for Statutory payments to support Veterans' Organizations.

Funding to authorize the listing and adjustment of Grants

• \$1 amount is required as a technical adjustment in order to provide the opportunity to seek the requited parliamentary approval
